It therefore comes as little surprise that now, they are somehow 'at threat' by the very same Municipal Law Enforcement Office whose officers I have exposed for abusing their authority and for violating Section 7 of the Charter of Rights and Freedoms, "right to life, liberty, and security of the person", and for breaching the January 27, 2023 ruling of Justice Michael J Valente, Superior Court of Justice - Court File No.: CV-22-717 that can be downloaded from
